

	National Priorities Project's <u>Cost of War counter</u> , designed to count the total money appropriated for the Iraq and Afghanistan wars, will reach the \$1 trillion mark on May 30. At nearly the same time, Congress likely will have approved an additional estimated \$37 billion for the wars in Afghanistan and Iraq. Initial projections of this spending will add \$3 billion to Iraq war costs and \$34 billion to Afghanistan war costs. In a recent speech to the Navy League's annual Sea-Air-Space Exposition, Secretary of Defense Robert Gates pointed to just a few of the many extreme cases in which US defense outweighs that of other countries:

- The US operates 11 large carriers, all nuclear powered. In terms of size and striking power, no other country has even one comparable ship.
- The US Navy has 10 large-deck amphibious ships that can operate as sea bases for helicopters and vertical-takeoff jets. No other navy has more than three, and all of those navies belong to pure allies or friends. Our Navy can carry twice as many aircraft at sea as all the rest of the world combined.
- The US has 57 nuclear-powered attack and cruise missile submarines again, more than the rest of the world combined.
- Seventy-nine Aegis-equipped combatants carry roughly 8,000 vertical-launch missile cells. In terms of total missile firepower, the US arguably outmatches the next 20 largest navies.
- All told, the displacement of the US battle fleet a proxy for overall fleet capabilities exceeds, by one recent estimate, at least the next 13 navies combined, of which 11 are our allies or partners.

Call for Papers: Proposals are invited for the Eurasian Peace Science Conference which will take place on January 7-8, 2011 at Koc University, Istanbul, Turkey. House Resolution 2478, the Lord's Resistance Army (LRA) Disarmament and Northern Uganda Recovery Act of 2009, supports stabilization and lasting peace in northern Uganda and areas affected by the Lord's Resistance Army.

The bill calls for the development of a regional strategy to support multilateral efforts to successfully protect civilians and for the authorization of funds for humanitarian relief and reconstruction, reconciliation, and transitional justice.

The LRA Resolution has already passed the Senate with bi-partisan support and is now in the House Foreign Affairs Committee. Although many Representatives have voiced their support for the bill, they must co-sponsor the Resolution to ensure the bill makes it out of Committee and onto the floor of the House.

The Lord's Resistance Army continues to commit atrocities and abduct children across three countries in Central Africa. Last year, in the Democratic Republic of Congo alone, the LRA reportedly killed a total of 849 people, abducted 1486, and displaced an additional 365,000 people from their homes. Based on the estimates of killings, the LRA's violence far outpaces other violent conflicts in the region, yet garners far less attention.
