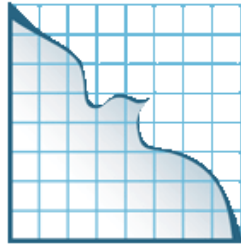

### Trickle-up wealth is making the American dream a myth

*Poor investment and dubious connections are ensuring the gap in income and opportunity keeps widening.*

"America likes to think of itself as a land of opportunity. But, while we can all think of examples of Americans who rose to the top on their own, what matters are the statistics: to what extent do an individual's life chances depend on the income and education of his or her parents?

Figures show the American dream is a myth. There is less equality of opportunity in the US today than in Europe.

"America has the highest level of inequality of any of the advanced countries - and its gap with the rest has been widening. In the 'recovery' of 2009-10, the top 1 percent of US income-earners captured 93 percent of the income growth. Other inequality indicators - like wealth, health, and life expectancy - are as bad or even worse. The clear trend is one of concentration of wealth at the top, the hollowing out of the middle, and increasing poverty at the bottom.

"It would be one thing if the high incomes of those at the top were the result of greater contributions to society, but the Great Recession showed otherwise: even bankers who had led the global economy to the brink of ruin received outsize bonuses."

### UNHCR launches flagship publication on State of the World's Refugees

*News Stories*, May 31, 2012

"UN High Commissioner for Refugees António Guterres warned on Thursday that factors causing mass population flight are growing, and over the coming decade more people on the move will become refugees or displaced within their own country.

"In comments marking the launch in New York of 'The State of the World's Refugees: In Search of Solidarity,' Guterres said displacement from conflict was becoming compounded by a combination of causes, including climate change, population growth, urbanization, food insecurity, water scarcity and resource competition.

"All these factors are interacting with each other, increasing instability and conflict and forcing people to move. In a world that is becoming smaller and smaller, finding solutions, he said, would need determined international political will."

The issue opens with an *interview* with the Indian development expert **Dr. Kshemendra Kumar Upadhyay**, who reflects on the caste system's implications for the Indian society. **Elisabeth Mikkelsen's** article reports a case study of how 'sensemakings' about conflicts change as they are enacted from the perspective of staff and management in a non-profit organization that participated in conflict management training. In continuation, **Bhimsen Devkota** and **Edwin van Teijlingen** present a study that explores the motivating factors of individuals who joined Maoists as health workers in Nepal. The article provides policy-relevant conclusions on how to promote sustainable peace and improve health care services in communities affected by conflict. In a similar vein, **Adam Baird** delves into the micro-foundations of peaceful society in his piece "*Negotiating Pathways to Manhood*." He

uses original empirical data collected in Medellín, Colombia, and a conceptual focus on masculinities to understand why some male youths negotiated a pathway to manhood without joining violent urban gangs.
