# **Applying Peace Economics in Dangerous Places**

Creating a sound economic policy and a stable macroeconomic framework is essential to societies recovering from violent conflict, yet few practitioners have the background needed to apply economic concepts effectively. USIP's new publication titled "Peace Economics: A Macroeconomic Primer for Violence-Afflicted States" provides a concise but broad overview of practical ways that sound macroeconomic fundamentals could be used to build stability in states that are affected by violent conflict.

The discussion extends beyond economic principles into the wider realm of social reconstitution, social contract, and social capital. Co-authors Jurgen Brauer and J. Paul Dunne examine recent case studies and illustrate the applicability of concepts presented in the book.

# Harvard's Belfer Center Offers Teacher Tools on Missile Crisis 50th Anniversary Cuban Missile Crisis

As part of its initiative to mark the 50th anniversary of the Cuban Missile Crisis, Harvard Kennedy School's Belfer Center for Science and International Affairs has created <u>tools for middle school, high school, and college teachers</u> to engage students in thinking about this decisive chapter in American and world history.

The Belfer Center research staff has crafted an **original lesson plan** to help students learn about the context and conduct of the October 1962 Missile Crisis. The lesson plan includes innovative in-class exercises and worksheets as well as **simulations** that allow students to role-play the crisis as members of the Kennedy Administration.

#### Global Justice Research Fellowship

St. Anne's College, University of Oxford, UK in association with Oxford Transitional Justice Research and the Centre for Criminology

The Governing Body of St Anne's College invites applications for the Global Justice Research Fellowship tenable from January 1, 2013. Applications will be considered from graduates or equivalent, women or men, in their second or subsequent year of doctoral research. Candidates registered for doctorates at other universities are eligible. Those candidates who have not completed their doctorate or equivalent, should provide evidence that they are likely to be in a position to submit their thesis within the first year of the Fellowship. The Research Fellow will have completed, or be close to completing, a PhD in Law, Politics, International Relations, Development Studies, Area Studies or another relevant discipline. The Fellow will have expertise in the broad

field of transitional justice, which concerns the processes and institutions employed by societies in transition following large-scale human rights violations such as mass conflict and/or repressive rule.

The Fellowship is on a fixed-term contract and is offered for one year in the first instance, and may be renewed for a second year provided that the Governing Body is satisfied that the Fellow is fulfilling the academic and other requirements of the Fellowship. The purpose of the Fellowship is primarily to foster research but it is expected that the Fellow will undertake 3 hours of teaching for the College or the Centre for Criminology per week.
