#### 2014 Global Peace Index Institute for Economics and Peace

Is the world becoming more or less peaceful? What are trends in global peacefulness?

The 2014 Global Peace Index will be released on the June 18th with launch events in London, Washington DC, Brussels, Berlin, Geneva, The Hague and New York City.

This year the analysis will focus on identifying countries most at risk of instability and conflict; it will explore the institutions that underpin peaceful societies, and look at the link between conflict risk, resilience and peacebuilding institutions.

Daniel Hyslop, Research Manager for the Institute for Economics and Peace, says he is excited about this year's Global Peace Index findings, and that we can expect to see some startling results. "The research that we are producing is a large step forward in assessing risk and opportunity for peace and conflict. The 2014 Global Peace Index report provides a powerful means of objectively quantifying current knowledge around the structural drivers of peace, information which is crucial for business leaders, development practitioners, governments and civil society."

#### Latest Jobs and Housing Reports Show Americans are Struggling More than Ever by Stephen Rosenfeld for *Alternet* May 20, 2014

The latest nationwide jobs and housing statistics released this week suggest that America is no longer a country where—for most people—the future is going to be better than the past.

The percentage of people in most age and education levels in jobs compared to 2008 is down. The number of people holding multiple jobs is up. Average hourly wages have barely grown, compared to 2008. The number of people who are willing to leave their job for a new one is down. All of those trends are in the latest report from the US Bureau of Labor Statistics (BLS)—and there are even more depressing economic signs.

#### Small Arms Data Observatory

An international consortium of researchers

On May 1, 2014 the Small Arms Data Observatory (SADO), an international consortium of researchers, launched its new website. While not based in any one location, many of SADO's resources and contributors are housed at the Joan B. Kroc School for Peace Studies at the University of San Diego. Initially, SADO will be devoted to the quantitative study of small arms - their manufacture, trade, and effects - in North America, Central America and South America, and eventually worldwide. It seeks to leverage the growing availability of large and medium-sized data sets, employ innovative statistical and geographic methods, and build online visualization tools, to bring greater transparency to the dynamics of small arms supply, demand, and use. Such transparency will in turn facilitate the crafting of more effective public policy to limit small arms to legitimate uses.



#### US Defense Spending vs. Global Defense Spending

In 2013, the most recent year for which complete data is available, the US approved \$600.4 billion in defense budget authority (fiscal year 2014 dollars). This figure includes funding for the Pentagon base budget, Department of Energy-administered nuclear weapons activities, and the war in Afghanistan.

This number accounts for 38 percent of total global military spending, putting the US far above any potential adversary. The next closest country, China, comes in at just \$112.2 billion, or 7 percent of total global military spending. No other country spent more than \$70 billion in 2013.
