UN agrees to toughest-ever sanctions against North Korea

The UN Security Council on Monday agreed on its toughest-ever sanctions against North Korea that passed unanimously after the United States softened its initial demands to win support from China and Russia.

The sanctions set limits on North Korea's oil imports and banned its textile exports in an effort to deprive the reclusive nation of the income it needs to maintain its nuclear and ballistic missile program and increase the pressure to negotiate a way out of punishing sanctions.

The Cost of Hurricane Harvey: Only One Recent Storm Comes Close By Kevin Quealy September 1, 2017 for *The New York Times*

It's far too early for a definitive estimate of the economic damage caused by Hurricane Harvey. Floodwaters still swamp large swaths of the Houston area and beyond, into far eastern Texas and Louisiana.

But three independent estimates from people who specialize in disaster and risk management show that the storm is likely to be the most expensive or second-most expensive natural disaster in the United States since 1980, the earliest year such comparable data <u>was kept</u> by the National Centers for Environmental Information. On Friday, estimates for Harvey from these groups ranged from \$70 billion to \$108 billion.

Report: The Road to Zero Wealth, How the Racial Wealth Divide is Hollowing Out America's Middle Class

In this report Institute for Policy Studies (IPS) looks at the racial wealth divide at the median over the next four and eight years, as well as to 2043, when the country's population is predicted to become majority non-white. IPS also looks to wealth rather than income to reconsider what it means to be middle class. In finding an ever-accelerating gap, they consider what it means for the American middle class and IPS explores what policy interventions could reverse the trends we see today. IPS finds that without a serious change in course, the country is heading towards a racial and economic apartheid state.

A Sharing Economy: How Social Wealth Funds can Reduce Inequality and Help Balance the Books by Stewart Lansley

CEOs in the United Kingdom earn more than 180 times the wages of an average employee. In the six years following the worst economic recession in recent memory, the world's top 100 companies almost doubled their market value to \$16.2 trillion. These are the signs of a modern economy which not only encourages but is founded on socioeconomic inequality. Stewart Lansley's book, A Sharing Economy: How Social Wealth Funds can Reduce Inequality and Help Balance the Books, is a timely exploration of the means of mounting a significant shift in the relations between capital, citizens and the state to improve the current capitalist model of political economy.

Tensions between the US and North Korea are reaching new heights, and the possibility for military conflict is growing. The US continues to avoid direct dialogue with North Korea, instead favoring sanctions and a strong-arm approach to bring North Korea to the table. At the same time, North Korea continues to progress its nuclear and missile capabilities. One small misstep by either side could ignite, in the words of General Joseph Dunford, Chairman of the Joint Chiefs of Staff, "a loss of life unlike any we have experienced in our lifetimes."
